IMPORTANT NOTICE (ELECTION 2025-28)

The following guidelines are hereby issued for all Candidates contesting in the Elections (2025–2028):

- 1. On Polling Day, Candidates shall be permitted to enter the election venue only for the purpose of casting their vote. After casting their vote, they must leave the venue immediately.
- Only the authorized Polling Agent shall be allowed to remain inside the election venue on Voting Day. If the Polling Agent exits the venue at any time, re-entry will not be permitted.
- 3. No relievers or substitutes will be allowed for either Polling Agents or Counting Agents.
- 4. On Counting Day, only the Candidate and his/her duly appointed Counting Agent shall be permitted to enter the election venue.
- 5. On the day of voting, as 48 Candidates are contesting in two groups, each group may propose a maximum of 22 Polling Agents (i.e., one Polling Agent for each booth). Similarly, candidates contesting in an individual capacity may also

propose up to 22 Polling Agents. However, the individual candidate contesting for the post of Control Board Member may nominate a maximum of 7 Polling Agents only.
